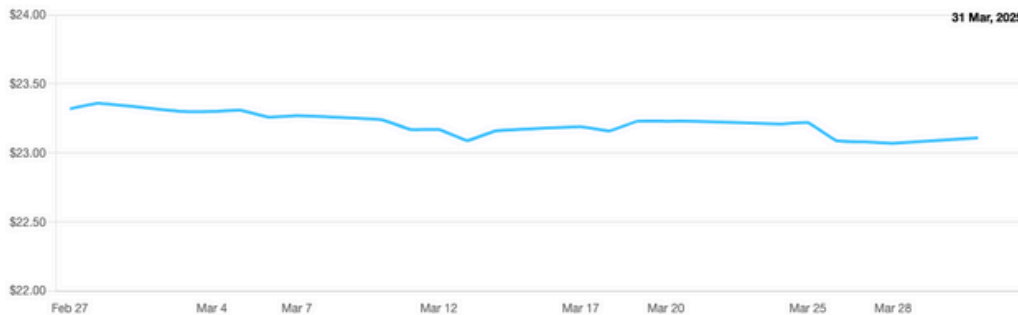

## MARCH 2025 SUMMARY

For the month ending on March 31st, 2025, the IDX Dynamic Fixed Income ETF (DYFI) returned **-0.67%**. Short-duration credit allocations negatively impacted returns as credit spreads widened significantly toward month-end. Positions in short-term treasuries, mortgage-backed securities, and long-duration treasuries remained relatively flat. The portfolio maintains a similar positioning entering April.

For April, we believe it's crucial to temporarily reduce exposure to credit markets as expectations realign and spreads widen to levels that better accommodate economic fluctuations. As trade policies continue to develop, we favor a portfolio primarily comprised of cash and treasury securities. Cash provides downside protection while maintaining flexibility to capitalize on market dislocations and emerging opportunities.

Treasury bonds present a distinctive opportunity given the potential economic scenarios: recession with disinflation or stagflation. While we don't engage in specific macroeconomic forecasting, we view both outcomes as having meaningful probabilities. The positive convexity of treasury bonds offers superior risk/reward compared to most fixed income instruments at present. When combined with cash or short-term treasuries, longer-dated treasury bonds create an attractive "lose less/make more" proposition.

We expect ongoing market, economic, and political volatility as the new administration implements its agenda. Recent equity declines and falling yields suggest caution, as markets typically anticipate economic shifts in advance.

Despite these cautionary signals, we observe few fundamental weaknesses in the broader economy that would warrant major concern. Nevertheless, recognizing that conditions can rapidly evolve, we remain committed to our dynamic investment approach.
